If you need assistance in any way, please call or come by the office. If you do not have property to be assessed in Stone County this year, please return this form so stating, so your name may be removed from tax rolls.

INSTRUCTIONS: NOTICE TO TAXPAYER

1. Deadline for return.

If you were a resident of, a property owner in, or operated a business in Stone County Missouri as of January 1st, please fill out the assessment list and return it to the Assessor's Office **BY THE FIRST DAY OF MARCH**. Businesses should file a "Business Personal Property Declaration" form. Please call us and we will send you one of these forms.

If you moved from Stone County before January 1st you will not owe taxes in Stone County. Please return this list stating your new address and date moved.

Failure to return your Assessment List will result in a Penalty.

Late Personal Property Lists - Sec. 137.280 of SB 62 requires the assessor to assess a penalty on any person who fails to return his personal property tax list by the first day of March.

2. Is your Name and Address correct?

If your name or mailing address is incorrect, please scratch through the incorrect information, and write the correct name or address on front of the form. Your tax bill will be mailed to the address given. Do we have your legal residence in the right school district and fire district on the front of the form? If not, please correct.

3. Did you receive more than one personal property assessment list?

If you received a duplicate blank under a different spelling of name or address, kindly return it to us with the notation "Duplicate" so we can correct our records.

4. Are you leasing a vehicle?

DO NOT Report Leased Vehicles on this list. Your leasing company will provide us with this information.

5. Do you own a Mobile Home?

In 1991, the Missouri Legislature passed House Bill 608, which states "Manufactured Homes (Mobile Homes)" shall be assessed as Personal Property, unless converted to Real Estate. Mobile Homes will continue to be valued by the same method, assessed at the same 19% of value, therefore this new law will not affect the amount of taxes you pay.

1. If you own both the Mobile Home and the Land, the Mobile Home will be included on the Real Estate Tax Statement.

2. If you do not own the Land, where the Mobile Home is parked, the Mobile Home will be included on your Personal Property Statement.
